You are invited to join the Exploring Joara Foundation on a European/ Sports Car tour and poker run.

You are invited to join automotive enthusiasts from all over the South East in touring the North Carolina Mountains and foothills on October 23 2010, hosted by the Exploring Joara Foundation.

There will be five stops on the tour and you can check-in and pick up cards at any of these stops starting at 8:30 am. The tour will end at the Catawba Meadows Park in Morganton NC and we will award the Touring Joara touring badge and give out prizes for poker hands from 2:30 till 4:00. Tour details will be provided upon registration but are also available on the Exploring Joara web site www.exploringjoara.org.

This touring event will take you on some of Western North Carolina's most scenic and historic roads. On your route you will see Swan Ponds circa 1848, Bellevue Plantation circa 1823, Cedar Grove Plantation circa 1825, Arney's Chapel circa 1900, The site of Cherry Hill Plantation founded in 1825, the Henderson Mill founded 1806, JOARA and the site of the Spanish Fort San Juan 1540, The site of the skirmish of Winding Stair in June 1864 and beautiful Lake James.

Upon registering, you will be provided an 'Accommodation List' of overnight lodging so that you may make your own individual overnight plans and reservations, plus a list of driving and traveling tips to prepare yourself for North Carolinas mountain touring. Your registration fee will also include a tour map, directions, points of interest, and a Tour badge. Most of these items will be available at the tour check-in. Tour fees for the car driver are shown on the registration form.
